
• Formed on October 15, 2015


- Specialty finance company focused on providing direct lending solutions to middle market companies
- Nontraded BDC raising capital through private offerings
 - Investors make capital commitments to purchase shares of common stock on an as-needed basis
 - The Company raised \$5.5 billion in total capital commitments from its investors
- The Company completed its IPO on July 22, 2019
 - Issued 10 million shares of its common stock at \$15.30 per share for net cash proceeds of \$141.3 million
- The Company's common stock began trading on the NYSE under the symbol "ORCC" on July 18, 2019
 - 2nd largest publicly traded BDC

Owl Rock Capital Corporation Loan Portfolio






Owl Rock Capital Corporation Closing Price

 - \$2.2 billion in capital commitments with \$1.6 billion undrawn as of September 30, 2019
- Commenced loan origination and investment activities on August 10, 2018
 - Made its first portfolio company investment in September 2018






